

## NOTICE AND DISCLOSURE TO LANDRUM'S CLIENT

Landrum Staffing Services, Inc. has been retained by the Episcopal Diocese of the Central Gulf Coast (Landrum's Client) for the limited purpose of providing consumer reports and/or investigative consumer reports relating to the person named below (Client's Applicant). The Fair Credit Reporting Act, as amended by the Consumer Credit Reporting Reform Act of 1996, requires Landrum Human Resource Companies, Inc. to advise employees and conditionally hired applicants that a consumer report and/or an investigative consumer report may be obtained at any point before or during employment from a consumer reporting agency and used for employment purposes. Information derived from these reports may be disclosed to the Episcopal Diocese of the Central Gulf Coast (Landrum's client) in consideration for employment. Consumer reports and/or investigative consumer reports may be generated using any name, or other information, identified by you in the new hire packet.

A "consumer report" is a written, oral, or other communication of any information by a Consumer Reporting Agency (CRA) which bears on an individual's credit worthiness, credit standing, credit capacity, character, general reputation, personal characteristics, or mode of living which is used or expected to be used or collected in whole or in part for the purpose of serving as a factor in establishing your eligibility for employment purposes or any other purpose authorized under the Fair Credit Reporting Act.

An "investigative consumer report" is a consumer report or part thereof in which information on your character, general reputation, personal characteristics, or mode of living may be obtained through personal interviews with neighbors, friends, or associates with whom you are acquainted or who may have knowledge concerning any such items of information. Your rights under the Fair Credit Reporting Act, Section 609, are summarized on the following page.
